**PROGRAM DESCRIPTION:** Second-year students complete the 1500 hours of required instruction learning advanced skills in styling, hair coloring, permanent waving, facials and manicuring. Students will also study anatomy and physiology, professionalism, and salon management in relation to cosmetology. Upon completing this program and passing the State examination, students become licensed and are prepared to be employed in a salon. Students also pursue 2 and 4-year postsecondary degrees in business, fashion design, or related fields. Some students use their license to work while continuing their education.

**MAJOR LEARNING OBJECTIVES:**

1. Develop professional practices and procedures in salon retailing and salon business to be successful in the industry.
2. Demonstrate mastery in manicuring and pedicuring.
3. Analyze and perform proper techniques and procedures of the skin.
4. Analyze state laws and regulations pertaining to employment in and operation of a cosmetology enterprise.
